Requirements And Costs To Transfer A Domain Name:

- 1. If you are an existing Aspedia web client no admin cost is charged for the transfer and the only cost applicable is if there are automatic renewal fees associated with the transfer. See costing section below for renewal fees due upon transfer.
- Customers that do not have web services with Aspedia will include a \$25.00 admin transfer fee, plus a renewal fee if applicable. See 2. costing section below for renewal fees due upon transfer.
- 3. If a domain is nearing expiry, some registrars lock the domain for transfer during this period. In this case, it is suggested that you contact your current provider to either unlock the domain or renew the domain with this provider and then undergo the transfer process after renewal.
- All domains that have either mail or web services attached that are live to the internet, incur an annual Domain Name Hosting fee of 4. \$110.00. DNS Hosting makes your domain live on our nameservers so that it is visible to the internet.

When mail changes over, email will cease to be received using the current format that the client uses and will start to be received via our mailserver and using the Aspedia mail system.
